The key revisions to the original bylaws include the following: • Clarification of the EDTF US Board membership to be an independent decision-making body as required by the US law, • Requirement for each EDTF Board Member to be accountable on an individual basis as required by US law. • Setting a term limit for the board members and putting in place a process to allow new Board members to join. • Provision of flexibility to the Board to establish an operating budget. While volunteers will continue to be the backbone of EDTF's existence, a sustainable and growing organization can not FULLY depend on

volunteers who could only put in the time whenever they could and who could occasionally leave with no mechanism to retain the institutional experience. The operating budget will support day-to-day operations and fundraising activities in the US, and work with implementing partners in monitoring funded projects in Ethiopia. It will keep its operating budget lower than the federal industry standard rate of 10%, often used as a benchmark for federal contracts and efficient nonprofits. EDTF also wants to reiterate that no funds donated through December 31, 2020 will be used for operating expenses. In fact, we notified all donors that the operating budget changes would only come out of new donations after January 1, 2021.
