While volunteers will continue to be the backbone of EDTFs existence, a sustainable and growing organization can not FULLY depend on volunteers who could only put in the time whenever they could and who could occasionally leave with no mechanism to retain the institutional experience. The operating budget will support dayto-day operations and fundraising activities in the US, and work with implementing partners in monitoring funded projects in Ethiopia. It will keep its operating budget lower than the federal industry standard rate of 10, often used as a benchmark for federal contracts and efficient nonprofits. EDTF also wants to reiterate that no funds donated through December 31, 2020 will be used for operating expenses. In fact, we notified all donors that the operating budget changes would only come out of new donations after January 1, 2021.
